HORSE AND RIDER SAFETY

I board horses for people and find that my barn becomes theirs as well for the time the boarders are there. I try my best to keep the place safe and let my boarders know that there are some things they shouldn't be doing in the barn like smoking cigarettes. I also store some hay in the barn and am always careful about how it's stacked, especially when it's fresh from the field, and that it isn't going to burn my barn down. Fire is a danger I've lived with forever and desperately want to avoid at all costs. I also am concerned about fire with my living quarters trailer and the vehicle that hauls it.

The closest I've come to having a fire at my barn was the day that a boarder parked her Jeep near the barn front door to just run in for something. We chatted a moment and then smelled smoke. We ran outside and her car motor was on fire. Foolishly she put it in neutral and we

pushed it away from the barn and THEN went for a fire extinguisher. I guess it's a toss-up as to whether we should have run for the extinguisher before pushing the car or whether it was wise to push it at all. In any case we got the fire out and the barn wasn't hurt. Somehow neither of us was burned.

I also have experienced having a fire at the rear of my truck at a ride. Apparently my trailer wiring shorted out and there was smoke and then flames. A quick thinking man nearby put it out with an extinguisher. I was very lucky to not have my truck burn up.

My safety suggestion: Have lots of fire extinguishers around the barn in plain sight and know how to use them. Also have one in your trailer and your truck. In some towns your local Fire Department will inspect your barn and give you suggestions on what you can do to prevent fires. (Some fire departments will re-charge your fire extinguishers, if they need it.)
