ECTRA MINUTES ANNUAL MEETING Holiday Inn and Suites, Grantville, PA February 24, 2018

The meeting was called to order at 5:10 pm by president, Wanda Stazick.

The February 4, 2017 Annual meeting minutes were read by secretary, Jeannette Cole. Minutes were unanimously approved by the membership.

The 2017 year end treasurer's report was given by treasurer, Ellen Tully. Accounts are as follows: Checking = \$13,277.98, Savings = \$40,385.13. Ellen noted that ECTRA holds trail funds that are obtained via donations and overseen by Dan Gruen, Trail Preservation Chairperson. Year on year income

is down \$6875.11 due to the purchase of score sheets, purchase of awards, reduced drug fee collection income, and higher than budgeted amounts for 2017 annual meeting. Motion made to accept the treasurer's report as presented by Louise Lester, seconded by Kate Vogel and unanimously approved by the membership

President Wanda Stazick announced the results of the election. Megan Thompson elected as treasurer, Louise Lester and Kat Waters elected as BOD members (term expiration 2020), Wanda Stazick as president, Esther Fiddes as vice president, Jeannette Cole as secretary. Remaining board members include Becca Watchel, Kate Vogel and Dr. Joan Hiltz. Wanda thanked the outgoing board members, Bill Lasher and Char Jewell, as well as the outgoing treasurer, Ellen Tully.

New business included an open discussion about the Annual meeting format. It was announced that Char Jewell will again chair the event. Follows are comments received from the membership:

- Quality of the speakers over the last several years has been excellent
- Educational aspect of the speakers has been excellent
- Opposed to having a set location each year for the meeting. Like that it bounces between New England location and Pennsylvania location.
- Membership feels that the turn out for the event is very good. One third of the ECTRA membership attends the event.
- Like the three day format
- Think the number of speakers and length of the presentations might be shortened.
- Perhaps do one in-person speaker and one live webinar speaker. Some members didn't like the idea of having to watch a speaker on a screen.
- Part of the goal for the annual meeting is to bring people together face to face. Having personal interaction is important.
- Perhaps invite other groups in the area – other horse disciplines might be interested in horse physiology. Noted that someone locally would need to help in the publicity if this was the case.

Other new business included a discussion on welcoming new members. Suggestions included:

- Feature article in the newsletter about new members

- Identifying gift that can be hung on a saddle at events so all people know this person is new to the organization
- Special new member reception at the annual meeting
- New members stand and be recognized at the annual meeting or rides
- Better welcome packets when a new person joins
- Informal welcome and encouraging articles regarding our sport on social media
- Rider handbook sent to new member
- New member welcoming committee formation (Dodie Sable volunteered to share what she had put together)
- Mentor program? What happened to this?

Other new business included a discussion on having multiple CDRs in a weekend at events. Ride Managers might consider this request from membership.

The Board will include the open discussion items at their next board meeting (March 18, 2017) and report back to the membership via BOD minutes.

Motion to adjourn the meeting at 6:10 pm was made by Mary Coleman, seconded by Louise Lester and unanimously approved by the membership.

RIDE SAFELY

“At a ride in Connecticut in 2001, at Fryeburg in 2010, at Leverett in 2012 I had the miserable effect of heat sickness. I hope to never have it again but as you can see I don’t learn easily having experienced it 3 times. My symptoms were nausea, light headedness, feeling VERY hot, and weakness. This was caused by not enough water in my system. I’m not sure about electrolytes because I know more about my horse’s need for them than mine. I don’t remember that any of these rides were exceptionally hot but when in competition and enjoying the day we don’t always pay attention. The rule of thumb is that if the temperature and humidity percentage added together is over 150 you should be very careful to stay hydrated. This is the same for your horse. The problem comes when you don’t have a thermometer or hygrometer to look at so you have to go by what you are FEELING. It’s also important to pay attention to your horse. I’ve noticed when I’m riding that if the horse isn’t sweating as much as I think he should for the temperature and possibly he hasn’t been drinking at every chance he gets he might be dehydrated. I’ve been told that when a horse or human is dehydrated they don’t have the thirst mechanism working which is caused by the lack of water. It doesn’t make sense but I’ve been assured that’s the case.

The answer is to be hydrated before the ride, as well as your horse, and keep drinking throughout the day. I think that electrolytes are important but each individual has his own requirements and this comes with experience as to how much you and your horse need. As for that horse like my Tap who didn’t seem to want to take the time to drink, it’s a problem for which I really don’t know the answer. In Tap’s case I let him decide and hoped that it would carry him through which it did. I still rode along worried and I guess I worried more about him than I did myself. Lesson learned by me for the future.

My safety suggestion: Condition you and your horse well before going to a ride in all conditions of weather and make an effort to keep water coming to you and your horse throughout a ride.”

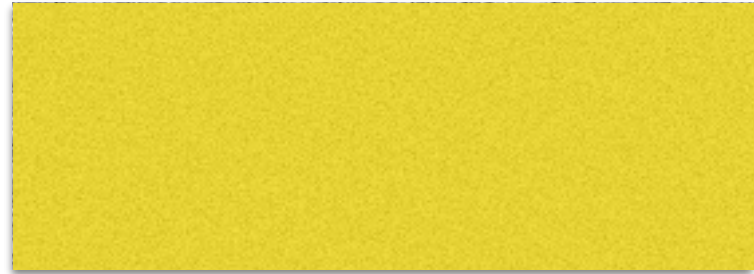
