### SCENES FROM THE MAINE SPRING RIDES

The Summer Solstice has come and gone, and the days are getting noticeably shorter, but some of the best riding of the year is still ahead. No mud, the deer flies will soon be gone, most of the heat and humidity will have lessened, and we can look forward to beautiful fall foliage in September and October.

The one hazard is ground wasps or yellow-jackets. If you are allergic to bee-stings, be sure to carry an Epi-pen or Benadryl in a fanny pack or jacket pocket, not a saddlebag, where it won't do you any good if you and your horse part company. These aggressive insects usually nest along the edges of the trail or under fallen logs; stay in the center of the trail and keep rein contact. Since it's usually the 3rd horse in a group that gets stung, riding in a big group is tempting fate — best to keep space between riders if at all possible.

Don't blame ride management for not finding the nests ahead of time: the wasps usually move their nests each year. Even if you mark the trail with a pair of riders, two horses usually isn't enough to stir them up.

On May 25-28, 2018 the Maine 80, 60, 30, 30, and CDR rides were held at the North Waterford Fairgrounds in Maine. These were Eastern Competitive Trail Ride sanctioned distance riding competitions. Entries of horses of several breeds were entered in their ride of choice: a 3-day 80 mile, a 2-day 60 mile, a 30 mile on Saturday or Sunday, and a CDR or Conditioning Distance Ride of 10 miles.

Twenty five horses and their riders were judged prior to their specific rides to set a base line of conditioning and lameness by Veterinarian Dr. Joan Hiltz from New Hampshire and Lay Judge Linda Glock from Vermont. Approximately half way through each ride the horses were looked over again as a safety check by the judges for metabolic and lameness deterioration in order to determine their ability to continue. At any time through the ride competitors were encouraged to communicate with the judges or ride management about any issue concerning them or their horse.

The trails used were single track and two track ATV trails through the towns of Waterford, Sweden, and Lovell.



**RIDE SAFETY TIPS**

During this year's Maine rides, judge Linda Glock mentioned that she had unpacked her fanny pack which she always rode with. She tried to open the jackknife in the pack and found that it was rusted solid and couldn't be opened. She told me that she thought this represented a good safety tip to convey. Linda is correct. How many of us pack our gear, trailer, truck etc. and never unpack it until we put our hands on the needed item. In my pack I've always carried a roll of Vetwrap and a pad in case of injury to rider or horse and the last time I tried to unwrap it I couldn't get it unwrapped because it was stuck together. I also found that the band aids I had in the pack were so old the glue on them wouldn't hold. In fact the paper cover was almost not able to be opened. I decided it was time to take some time to check my other containers to be sure all was ready to go i.e. the bottom of my tack trunk had a mouse bed in it.

When I inspected my truck all was there but the dating on the motor oil bottles was years old but I was told that was OK since they had never been opened.

My safety suggestion: Inspect your gear and vehicles at least yearly to be sure everything is ready to go and serviceable.

Char Jewell gave me another good subject to talk about this month. She was ponying a horse and was wearing a jacket with a hood that she had worn for years. Going under a branch the hood caught and she was pulled from the horse onto the ground. She managed to keep hold of the ponied horse so the other horse didn't run off. She said she was lucky in that she wasn't hurt badly and/or didn't have a long walk home.

I also almost had an accident if it wasn't for my great horse Tap. I ride with a sponge on a string and was told by another rider that it had come loose and was wrapping around my horse's hind leg every stride he took - he was trotting at the time! I was very fortunate that he didn't unload me and the sponge.

My safety suggestion: Be careful about the clothing you wear or have tied to you or your horse when riding. Anything flapping can be a problem to your horse or horses around you. They can also become a snag which can drag you off your horse.
